Adoption of East Hampshire District Local Plan: Housing and Employment Allocations

Adoption Statement

In accordance with the Planning and Compulsory Purchase Act 2004, Regulation 26 of the Town and Country Planning (Local Planning) (England) Regulations 2012, and Regulation 16 of the Environmental Assessment of Plans and Programmes Regulations 2004, notice is hereby given that East Hampshire District Council adopted the East Hampshire District Local Plan: Housing and Employment Allocations Development Plan Document on 7 April 2016.

The adopted Local Plan: Housing and Employment Allocations covers the administrative area of East Hampshire District Council excluding the area of the South Downs National Park Authority that lies within the District. The Local Plan: Housing and Employment Allocations primary purpose is to identify specific sites sets out the spatial vision, objectives, development strategy and policies to enable the delivery of sustainable development and communities in East Hampshire District for the period 2011-2028. Inspector Mr Jonathan Bore, appointed by the Secretary of State for Communities and Local Government, undertook an examination of the East Hampshire District Local Plan: Housing and Employment Allocations. The Inspector's report issued on 15 February 2016 concluded that the Local Plan is sound and legally compliant subject to the Inspector's main modifications pursuant to Section 23 of the Planning and Compulsory Purchase Act 2004.

The adopted version of the Local Plan: Housing and Employment Allocations incorporates all the main modifications set out in the Appendix of the Inspector's report.

The Local Plan: Housing and Employment Allocations, the Adoption Statement, the Sustainability Appraisal Report, and the Inspector's Report and all other relevant documents can be viewed on the Council's website (www.easthants.gov.uk).

Hard copies of the Local Plan: Housing and Employment Allocations are also available for public inspection at the local deposit locations listed below.

In addition, local libraries and information centres within East Hampshire District will be supplied with copies of the above documents for inspection. Details of library opening times can be found at the end of this statement.

Any person aggrieved by the Local Plan: Housing and Employment Allocations may make an application under Section 113 (3) of the Planning and Compulsory Purchase Act 2004 to the High Court on the grounds that the document is not within the appropriate powers and/or a procedural requirement has not been complied with. Any such application must be made promptly, and in any event, no later than 19 May 2016 (six weeks from the date of the adoption specified above).
