Adoption Statement

In accordance with the Planning and Compulsory Purchase Act 2004, Regulation 26 of the Town and Country Planning (Local Planning) (England) Regulations 2012, and Regulation 16 of the Environmental Assessment of Plans and Programmes Regulations 2004, notice is hereby given that East Hampshire District Council adopted the East Hampshire District Local Plan: Joint Core Strategy Development Plan Document on 8 May 2014.

The adopted Local Plan: Joint Core Strategy includes the Main Modifications recommended by the Inspector who carried out the independent examination of the Plan; together with the Council's Minor Modifications which were considered by the Inspector and subject to public consultation in the document "Further Proposed Modifications August 2013".

The adopted Local Plan: Joint Core Strategy covers the administrative area of East Hampshire District Council including the area of the South Downs National Park Authority that lies within the District. The Local Plan: Joint Core Strategy sets out the spatial vision, objectives, development strategy and policies to enable the delivery of sustainable development and communities in East Hampshire District for the period 2011-2028. An application must be made (Section 113 (4)) no later than the end of a period of six weeks from the date of the adoption of this Local Plan: Joint Core Strategy.
