Council Tax Application for carers/care workers to be disregarded in the calculation of the charge

A carer is a person who lives in the same property as another person to whom they provide care. This does not apply to a spouse or a parent caring for a child under the age of 18.

A care worker is a person who is employed for 24 hours or more a week as a volunteer care-worker by a charity or similar institution and receives remuneration of no more than £44 per week.

Here is a list of qualifying benefits. The applicant needs to receive anyone of the following in order to be considered for the reduction.

- Higher rate of attendance allowance under Section 65 of Social Security Contributions and Benefits Act) 1992.
- Highest rate of care component of Disablement Living Allowance under section 72 (4) (a) of that Act
- Enhanced rate of daily living component of Personal Independence Payment
- Increase in rate of disablement pension
- Increase in constant attendance allowance

IMPORTANT - we need to see photocopies of the benefits received in order to consider your application. Please note that the number of adults resident in the property may affect your entitlement to the reduction.

If you believe that you are a <u>carer</u>, please complete section 1 and sign the declaration in section 3. If you believe that you are a <u>care-worker</u>, please complete section 2 and sign the declaration in section 3. The attached certificate of earnings form should be completed and returned as instructed.
