Evidence of snap outs within the canopy. Recommend 30% crown reduction of whole canopy to reduce sail. Cutting branches by up to 6m back to good growth points leaving

a post works height of 14m and spread 28m (radius). T2 Alder. Located by front entrance. Lower branches covering street light. Recommend reducing multiple tertiary branches by growing under street light, cutting the branches by up 1.5m from tips.
