Proposal: This will be a single panel interpretation board with information about the Wealden Heath SPA SSSI.

The interpretation board has been designed to be consistent with others in the project area and designed to highlight the sensitive nature and special habitat of Shortheath Common. The board will measure approximately 1.2m in width with a maximum height of 2m. The structure will be made of oak, and the panel made of coated aluminium. The posts will remain in the ground for the duration of

the project (March 2025) and beyond for a minimum of 10 years.

These will be no deeper than 80cm. Once the interpretation board is in place, it will be fixed in place with Postcrete. Any excess spoil will be distributed locally. A scale drawing of the board will be

included in the attached documents.
