PROPOSAL: T1 Pine - 3 metre crown reduction of tops to relieve weight on bent stem. Prune 4 lower branches to 5/6 metres as overhanging public footpath. T2 Pine - remove approx 6 metres to make same height as rest of crown or discuss removal of whole tree as very low amenity value. T3 Pine - Large twin stemmed to be reduced by 2/3 metres of the branch length to healthy growth points in order to maintain size and prevent future branch failure. T4 Pine - To have a max of 2 metres reduced from tops to maintain natural crown balance. T5 Pine - to have top section reduced by 2 metres height by way of thinning out and a more balanced crown. T6 Pine - to have 2 metre crown reduction. To reduce a few side branches by a metre or so including 2/3 metres of one overhanging neighbours (No9) . T7 Pine - Larger limb overhanging neighbours garage reduce by 50% to healthy growth point. Reduce top crown by 2 metres. T8 Pine - has a strange twisted fork union - remove 2/3 metres from extended tops. T9 Pine - To have lowest branch removed. 6th branch up to be reduced by 3 metres and top to be reduced by 2/3 metres to balance with rest of trees canopy. T10 Oak - removal of branch smothering rhododendron back to stem of low branch. Removal of wrist sized branch to fork in branch. (TPO)
